Policy Statement

Registrants are responsible for managing their professional development by:

- Informing the ECI Technical Manager of additional professional development opportunities
- When in doubt if a professional development opportunity will qualify for Professional Development Hours (PDHs) contact the ECI Technical Manager for approval
